The MASA State Umpire Staff will be conducting three MASA State Umpire Clinics in 2008. The clinics are scheduled from 9:00 a.m. to 4:00 p.m. Doors will open at 8:00 a.m. for sign-in, umpire registration, and equipment sales.
